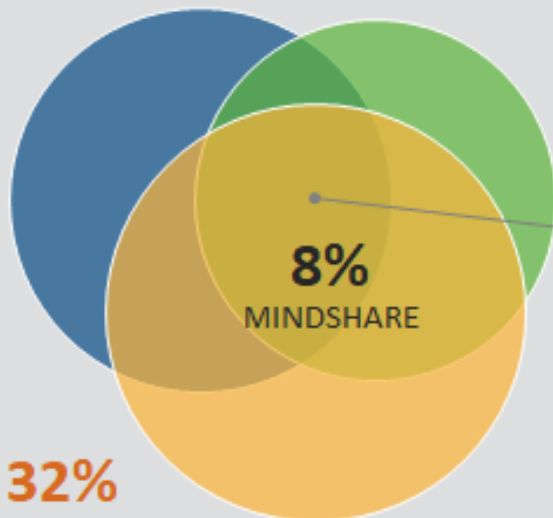

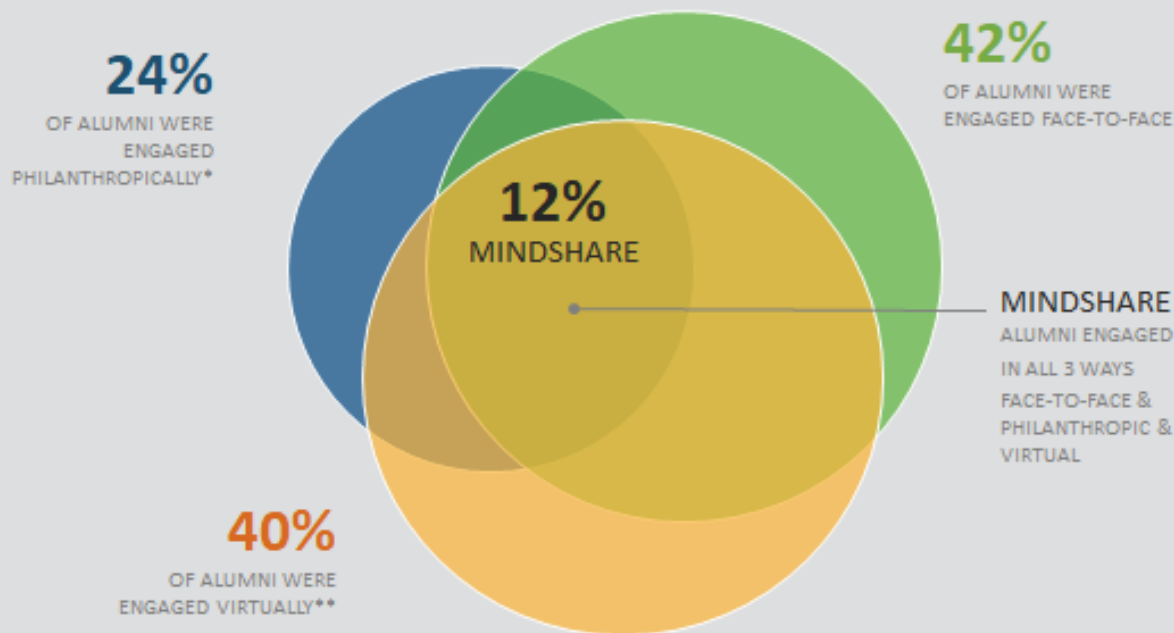

59% of all living Black alumni are engaged

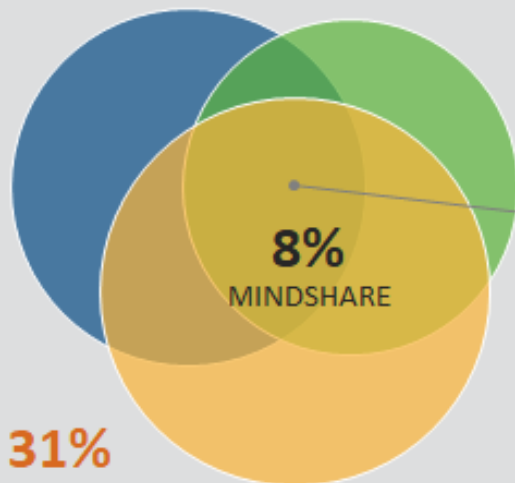

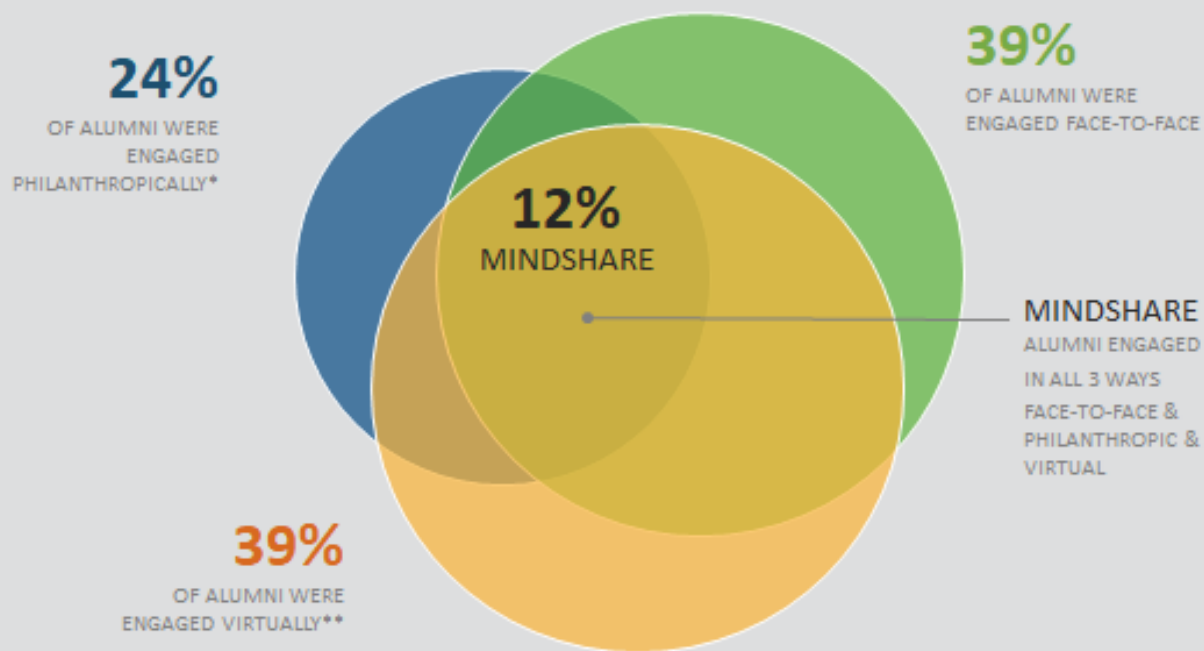
